In the pursuit of continuous improvement, the KC Group of Research & Professional Institutes in Pandoga, Una, meticulously analyzes teacher feedback to enhance the quality of education provided. For the session 2023-2024, a thorough analysis of teacher feedback was conducted, employing statistical analysis and graphical representations to ensure comprehensive results. Each item in the feedback was scored on a five-point scale, ranging from 'Strongly Disagree' to 'Strongly Agree', with a total of 17 teachers providing their valuable input.

The Internal Quality Assurance Cell (IQAC) spearheaded the analysis of the teacher feedback, meticulously scrutinizing each response. Following this analysis, the IQAC engaged in discussions with relevant authorities to deliberate on the suggestions provided by the teaching staff. Through collaborative efforts, the authorities then issued instructions to the respective departments based on the insights gleaned from the feedback.

Subsequently, the departments received directives aimed at fostering better quality improvement in curriculum design and the teaching-learning process. These instructions were tailored to address specific areas of concern and capitalize on opportunities for enhancement highlighted by the teacher feedback. By aligning instructional strategies and curriculum development with the feedback received, the institute aims to elevate the overall educational experience for both students and faculty.

The iterative process of soliciting, analyzing, and acting upon teacher feedback underscores the institution's commitment to continuous improvement and excellence in education. By valuing and incorporating the perspectives of its teaching staff, KC Group ensures a collaborative approach to refining pedagogical practices and curriculum delivery methods. 




Table 3: The course/ programme of studies carries sufficient number of optional papers




Table 4: Programmes outcomes of the syllabi is well defined






Table 6 : The course content fulfills the need of students




Table 7: Need to fully review the syllabus




Table 8: Students are disciplined and respect the staff members




Table 9: Institute provides opportunities for continuous development of staff




 Table 10: Equal opportunities for all staff is provided




 Table 11: Institute has adequate medical facilities and is equipped to handle medical and other emergencies





Table 12: Rest room, toilets, laboratory, playground, classrooms are clean and well maintained




 Table 14: Laboratory requirements including equipment, chemicals and specimens are regularly provided




Table 15: Computer facilities are made available for ICT based teaching to students.




Table 16: Good facility and encouragement to the teachers for their research




Table 17: Institute pays attention to conservation of environment and has taken initiative on implementing waste management practices.




Table 18: Authorities are approachable and accessible




Table 19: There is a mechanics for feedback, review and performance enhancement for the staff




TEACHER FEEDBACK ANALYSIS

objectives facilitate targeted skill development, fostering a learning environment conducive to critical thinking and practical application.

- 4. Importance of Vision and Mission Statements: Teachers emphasized the significance of clear vision and mission statements in achieving valuable course outcomes. This finding highlights the role of institutional values and objectives in guiding educational practices, emphasizing the importance of a cohesive educational framework.
- 5. Adequate Availability of Learning Resources: 90% of teachers noted the presence of a sufficient number of reading materials and digital resources at KC Group of Research & Professional Institute, Pandoga. This high percentage indicates a positive perception among faculty regarding the accessibility of resources, which is crucial for supporting diverse learning needs and enhancing the quality of education delivery.
- 6. The high satisfaction rate (97%) among faculty regarding their involvement in revising the course curriculum and syllabus reflects effective avenues for expressing viewpoints, fostering collaborative input, and ensuring alignment with educational goals.

SUGGESTIONS

- 2. Enhance teaching-learning experiences by prioritizing investment in smart classrooms, updating teaching tools, ensuring availability of advanced laboratory equipment, and expanding access to diverse reading materials to support comprehensive learning outcomes.
- 3. Ensure syllabus updates align with NEP-2020 guidelines to meet the evolving needs of education and industry standards.
